






Last month I told you that our lineage portion of weekly fee would be going up from

Swenson Park on April 15 was a perfect place for golf. Twenty-six players enjoyed a great day at the links. Everyone wants to come back next year. The weather was much improved over the rain or heat we have had in Stockton in previous times. Sunscreen was needed without being hot.

Competition continues to be very close. Winners seem to change every month. Sixteen (62%) won some money. First place went to Tom Dennin, Phil Kepp, Sol Robin, and Dennis Pachucki with 124. Second place (127) was decided after a tie breaker – Dave Vicencio, Manny Geronimo, Dan Lippstreu, and Ken Fanucchi. Third place was awarded to Joe Stanley, Sid Cruser, Ron Benge, and John Emerson. It took a lot of measuring tape to award Closest to the Pin on hole 5 to Jim Span with 44' 11". Hole 12 went to Dave Vicencio (8' 8"). Lowest Gross score went to Dan Lippstreu (77). The top winner was Sol Robin (\$31) having also won three Skins. In Flight A Phil Kepp won First Low Net over Ron Benge (72). In Flight B Isao Nishijima won Low Gross (92) and Dennis Pachucki won Low Net (72).

The Event Surveys continue to be very informative. There was an even split on the question of more logo gear. Half wanted more Shirts, Windbreakers, and Towels. Pace of play was very good today with an average of 3.92. Several were in under 4 hours 15 minutes, and all were done in 4 hours 30 minutes.

Golf is experiencing the highest registration for three events ever. It looks like a growth year. This is at a time when the SIR Branch 161 is going through some major changes. For the organization, attendance is down significantly. One reason is because of the cost and lack of quality of luncheons provided by the Discovery Bay Golf and Country Club. The SIR BEC has taken action to improve things by moving our luncheons to Trilogy. A bold move that should improve both concerns, but we will lose more members because of the distance to the new meeting site.

Golfers are offering an organization-wide challenge to help sustain and increase membership. We will try and increase not just golf participation but SIR Branch 161 membership throughout the remainder of 2025 to demonstrate support for the difficult, but quality decision made by the BEC. #### (revised 2019)

Prospective members must be sponsored by an active member.

## **Attendance Policy**

Luncheon meetings for the remainder of 2025 will be held on the first Tuesday of the month at Club Los Meganos at Trilogy in Brentwood. (There may exceptions when we need to hold our meetings on a different Tuesday, so please check the Meetings Calendar elsewhere in this newsletter).

Social hour is at 11.00am and lunch is at noon. All members are expected to attend Luncheon meetings unless prevented by illness, absence from the Branch locale, or acting as a caregiver to a spouse or companion. If you cannot attend, you are required to notify the Attendance Chairman by the Friday prior to the luncheon meeting or you may be charged for the luncheon.

Regular members missing three consecutive meetings without notifying the Attendance Chairman, or missing more than five (5) meetings within the last 12 months for any reason (not counting May and December), will have their membership reviewed by the Branch Executive Committee (BEC), and may receive a notice from the BEC of their decision to consider terminating the absent Sir's membership.
